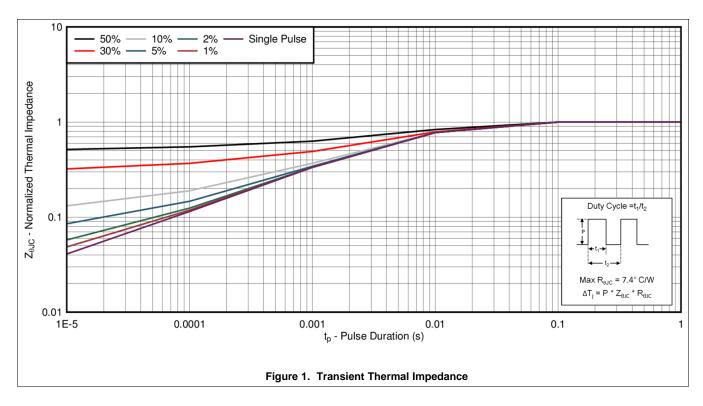

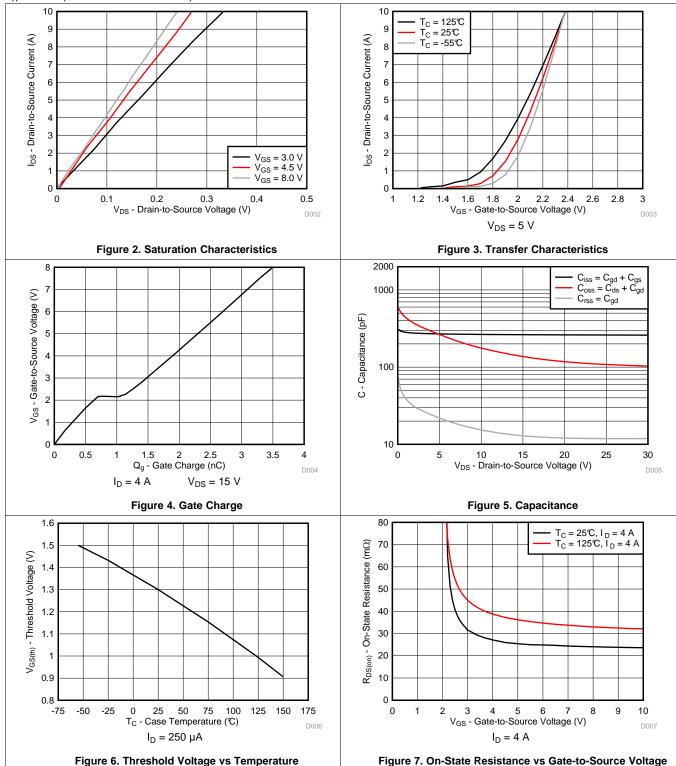

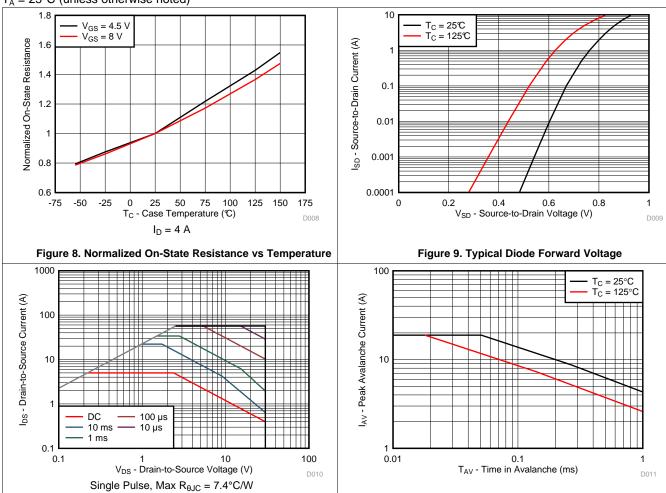

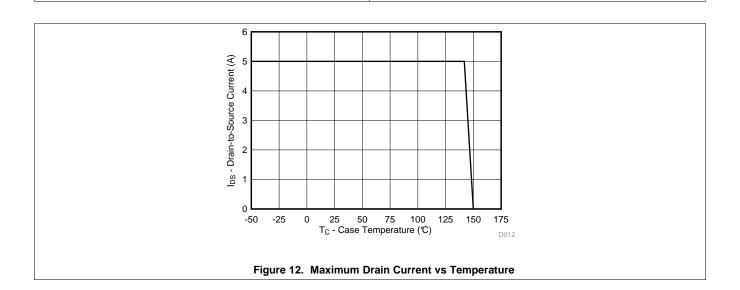


Figure 10. Maximum Safe Operating Area

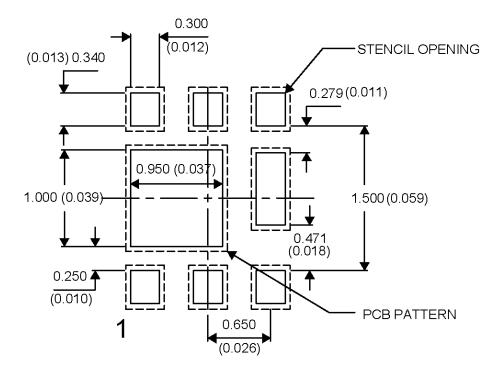


### 7.2 Recommended PCB Pattern

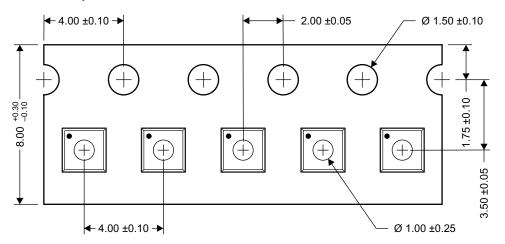
### 7.3 Recommended Stencil Pattern

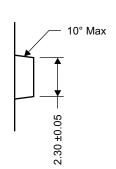


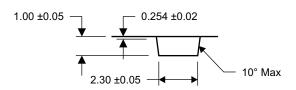
