Octal D-Type Latch with 3-State Output

The TC74VHCT573A is an advanced high speed CMOS OCTAL LATCH with 3-STATE OUTPUT fabricated with silicon gate C²MOS technology.

It achieves the high speed operation similar to equivalent Bipolar Schottky TTL while maintaining the CMOS low power dissipation.

This 8-bit D-type latch is controlled by a latch enable input (LE) and an output enable input (\overline{OE}).

When the $\overline{\mathrm{OE}}$ input is high, the eight outputs are in a high impedance state

The input voltage are compatible with TTL output voltage.

This device may be used as a level converter for interfacing 3.3 V to 5 V system.

Input protection and output circuit ensure that 0 to 5.5 V can be applied to the input and output ^(Note) pins without regard to the supply voltage. These structure prevents device destruction due to mismatched supply and input/output voltages such as battery back up, hot board insertion, etc.



Features

- Low power dissipation: ICC = 4 μA (max) at Ta = 25°C
- Compatible with TTL inputs: VIL = 0.8 V (max)

VIH = 2.0 V (min)

- Power down protection is provided on all inputs and outputs.
- Balanced propagation delays: tplH ≈ tpHL
- Low noise: VOLP = 1.5 V (max)
- Pin and function compatible with the 74 series (74AC/HC/F/ALS/LS etc.) 573 type.











SOP20-P-300-1.27A Unit: mm


