Typical Insertion Loss:



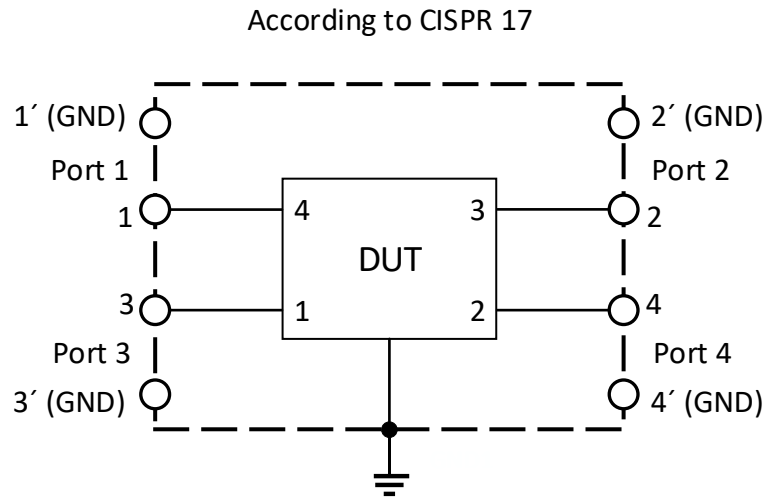
Typical Impedance Characteristics:

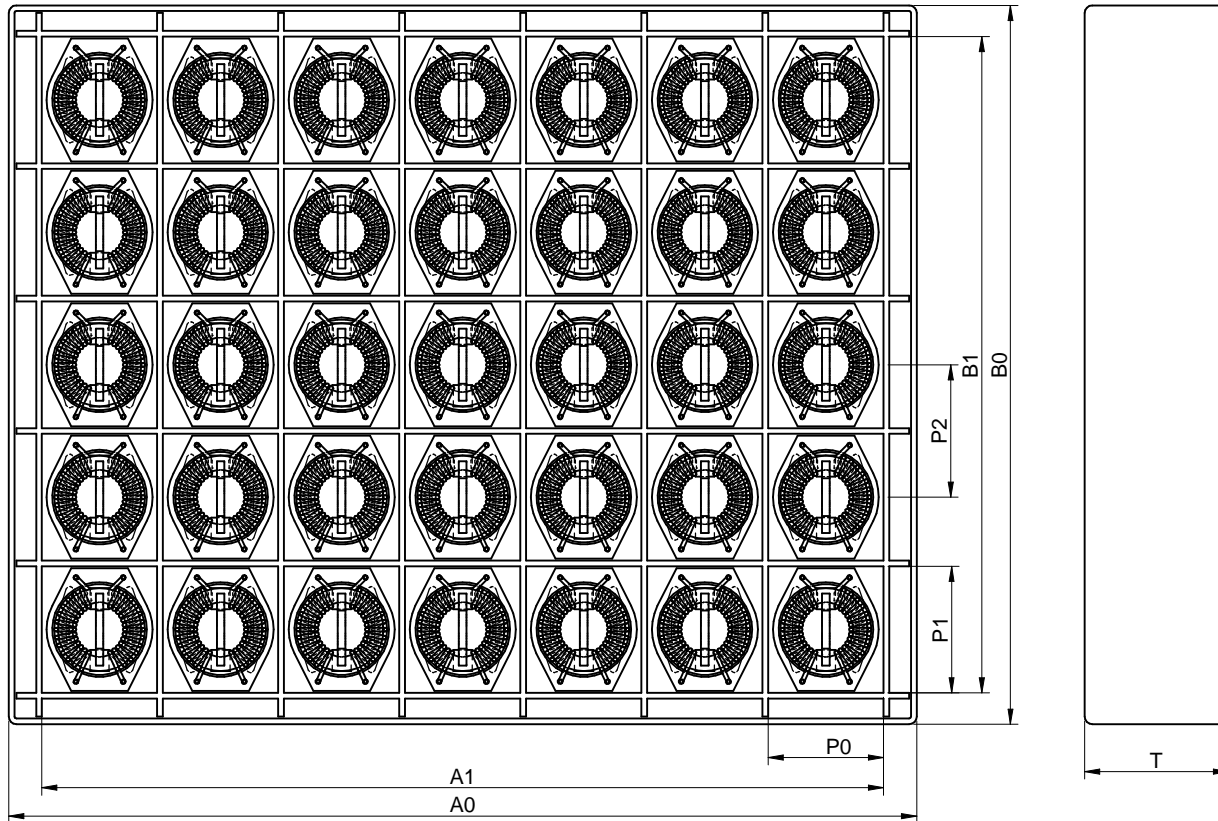

Derating Curve:

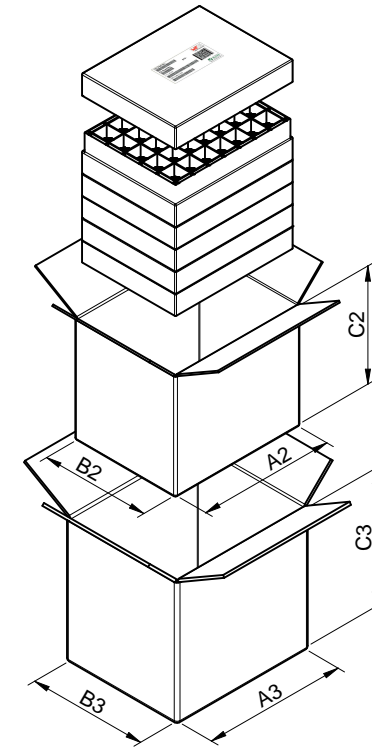

Soldering:



Storage Conditions:


