The 74ALVC00-Q100 is a quad 2-input NAND gate.

Schmitt trigger action on all inputs makes the device tolerant of slow rise and fall times.







Fig 7. Test circuit for measuring switching times








Fig 10. Package outline SOT762-1 (DHVQFN14)
