




TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted



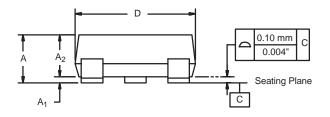

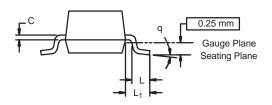
Square Wave Pulse Duration (s) Normalized Thermal Transient Impedance, Junction-to-Foot


