

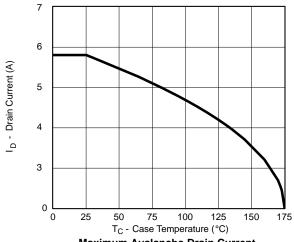


On-Resistance vs. Junction Temperature






Maximum Avalanche Drain Current vs. Case Temperature


Safe Operating Area




Normalized Thermal Transient Impedance, Junction-to-Case


