









Source-Drain Diode Forward Voltage





On-Resistance vs. Gate-to-Source Voltage




Single Pulse Power, Junction-to-Ambient










Current Derating*




Power, Junction-to-Foot





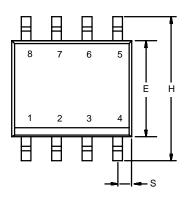
Normalized Thermal Transient Impedance, Junction-to-Ambient


