# HIGH SENSITIVITY MICROPOWER OMNIPLOAR HALL-EFFECT SWITCH

### **Description**


The AH1897 is a high sensitivity micropower Omnipolar Hall effect switch IC with an internal pull up and pull down capability. Designed for portable and battery powered equipment such as cellular phones and portable PCs, the average supply current is only 4.3µA at 1.85V. To support portable equipment, the AH1897 can operate over the supply range of 1.6V to 3.6V and use a hibernating clocking system to minimize the power consumption. To minimize PCB space, the AH1897 is available in a small low profile X1-DFN1216-4 (Type D) package.

The output is activated with either a North or South pole of sufficient magnetic field strength. When the magnetic flux density (B) perpendicular to the package is larger than operate point ( $B_{OP}$ ), the output will be turned on (pulled low). The output is turned off when B becomes lower than the release point ( $B_{RP}$ ). The output will remain off when there is no magnetic field.



Note: 4. C<sub>IN</sub> is for power stabilization and to strengthen the noise immunity, the recommended capacitance is 100nF typical.








When power is initially turned on, the operating V<sub>DD</sub> (1.6V to 3.6V) must be applied to guaranteed the output sampling.

















Average Supply Current vs. Temperature






**Sensor Location**
