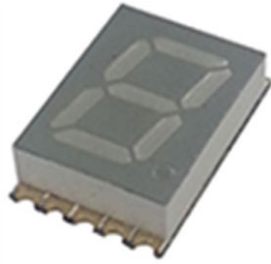

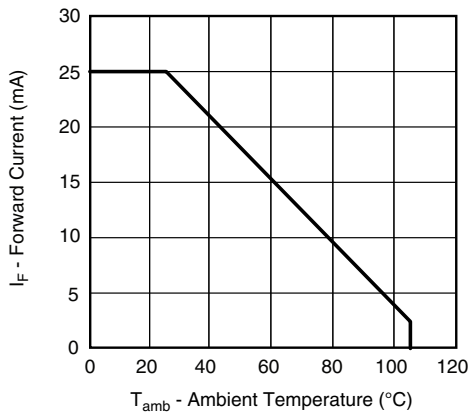


Fig. 1 - Forward Current vs. Ambient Temperature

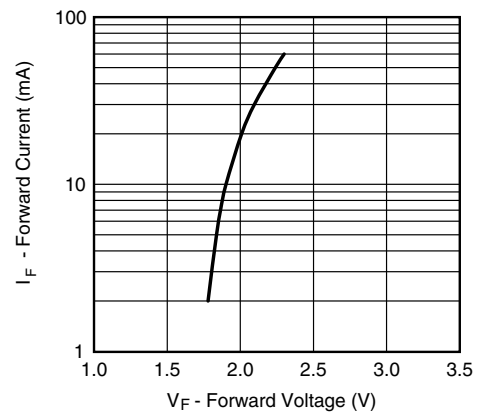


Fig. 4 - Forward Current vs. Forward Voltage

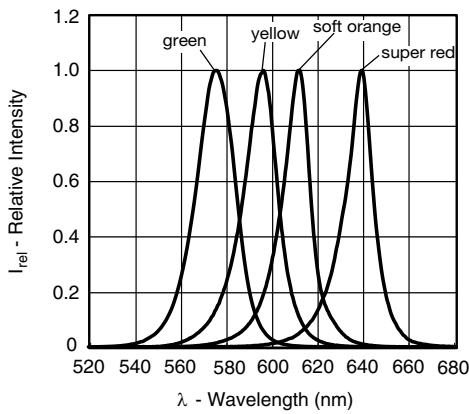


Fig. 2 - Relative Intensity vs. Wavelength

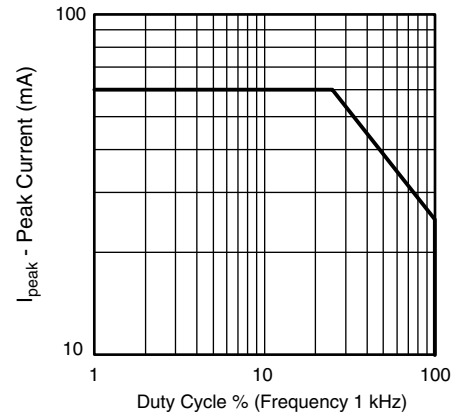


Fig. 5 - Peak Current vs. Duty Cycle

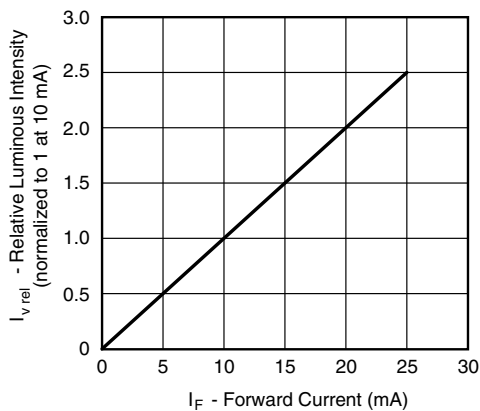
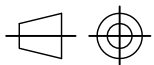
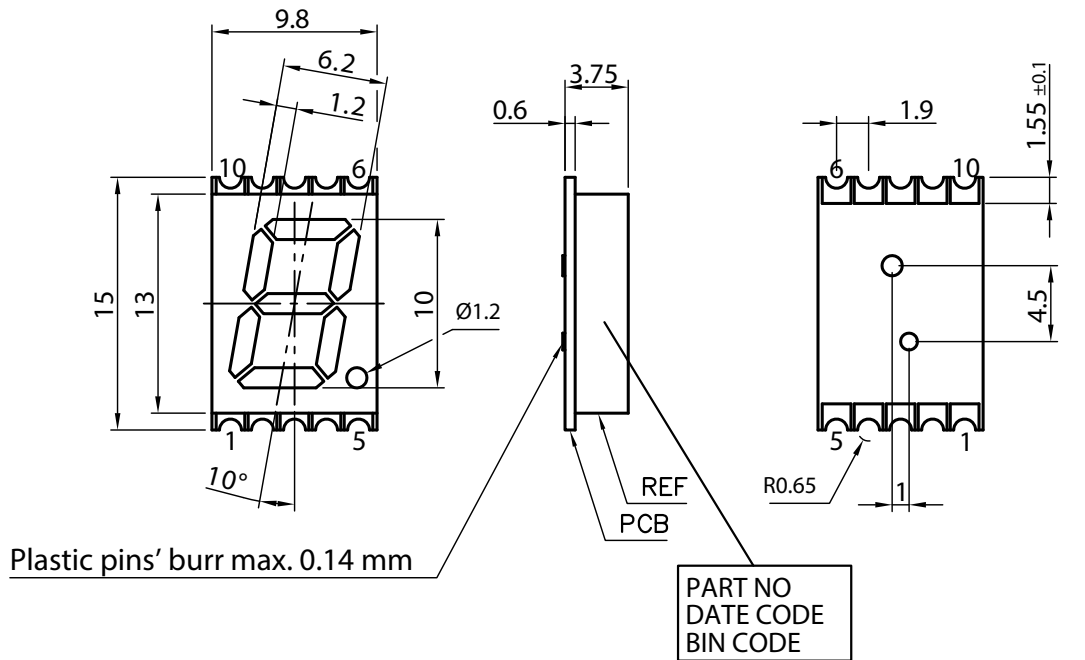


Fig. 3 - Relative Luminous Intensity vs. Forward Current

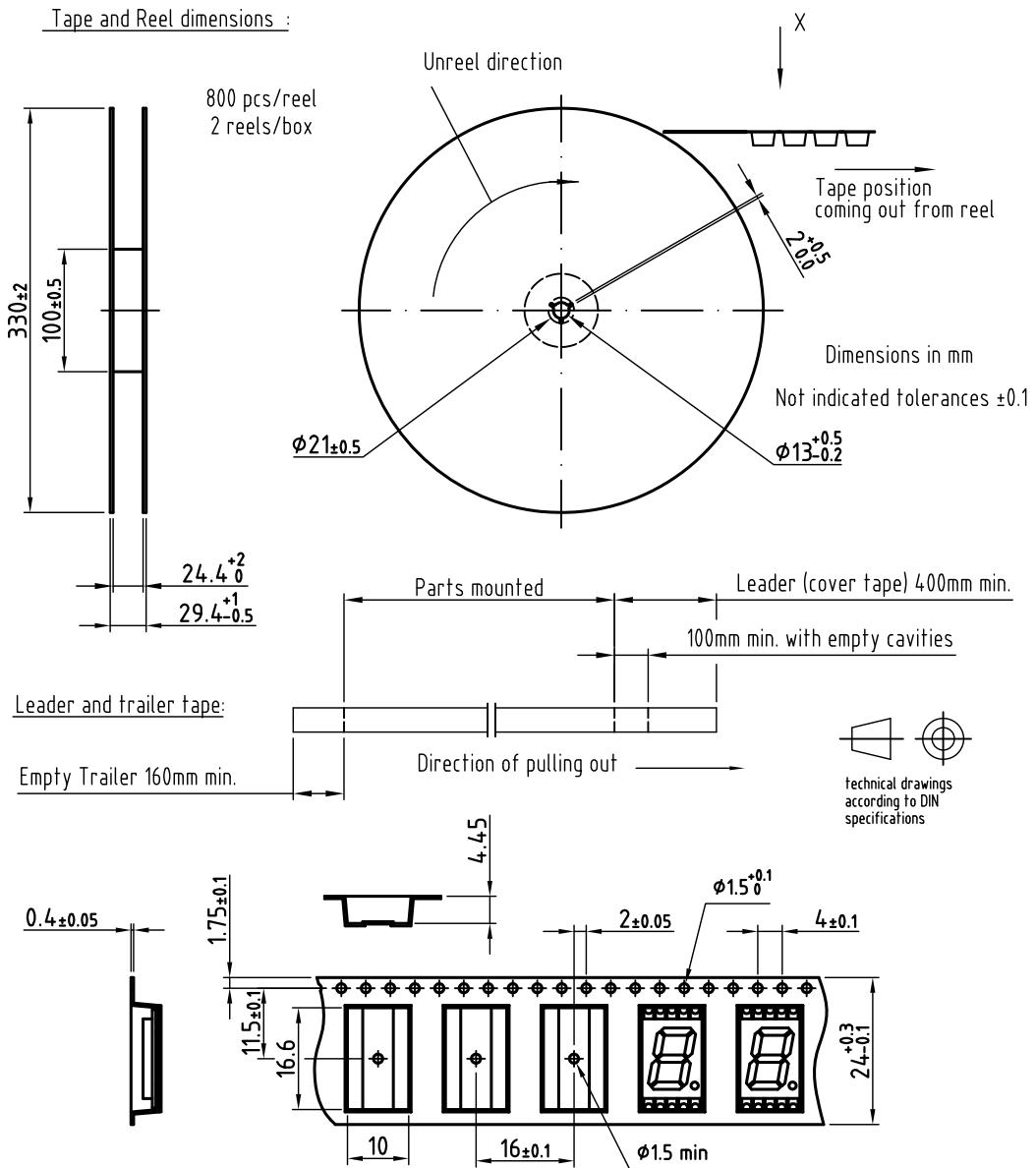

## TAPE AND REEL DIMENSIONS in millimeters



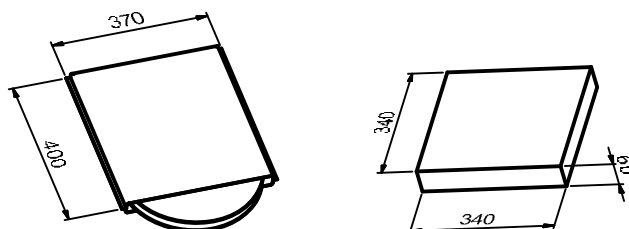

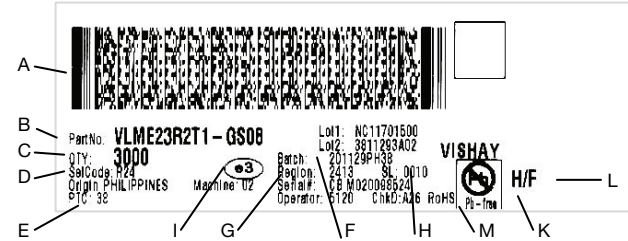

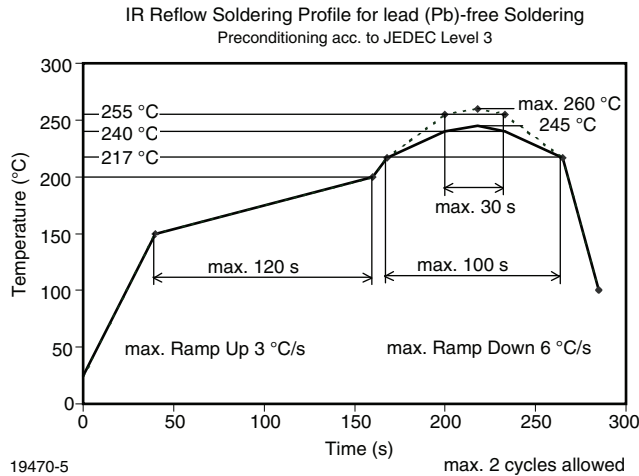
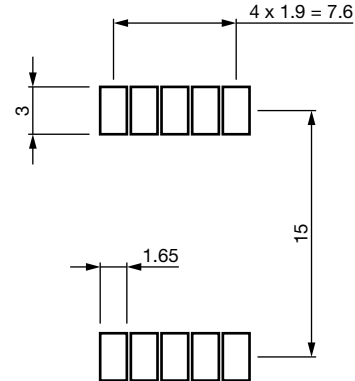


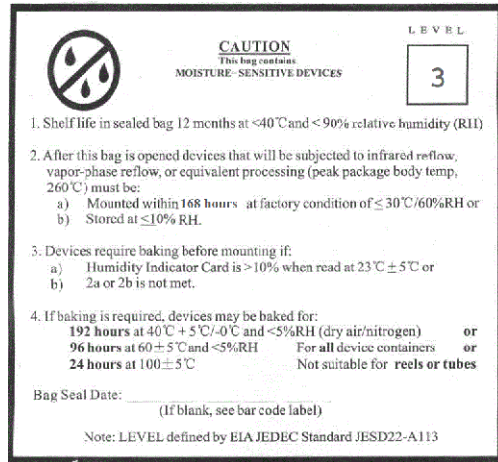
Fig. 6 - Vishay Lead (Pb)-free Reflow Soldering Profile (acc. to J-STD-020C)
