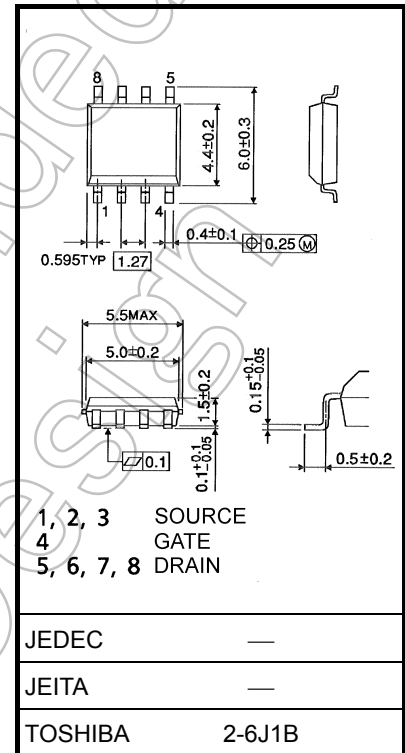

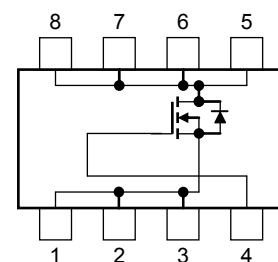

Circuit Configuration

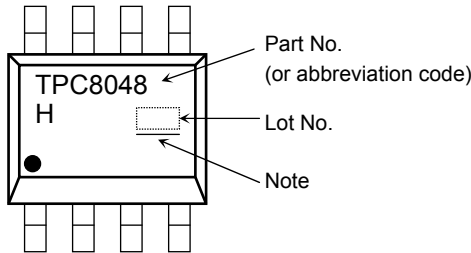
