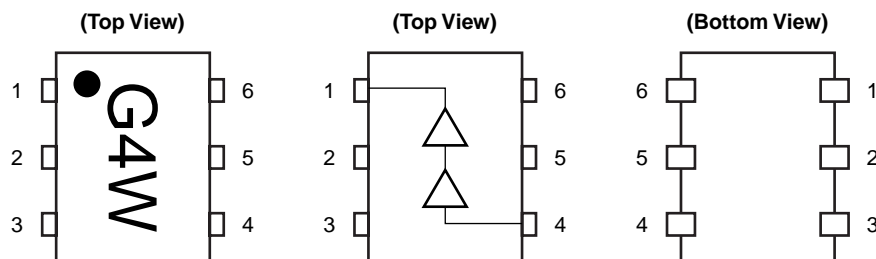

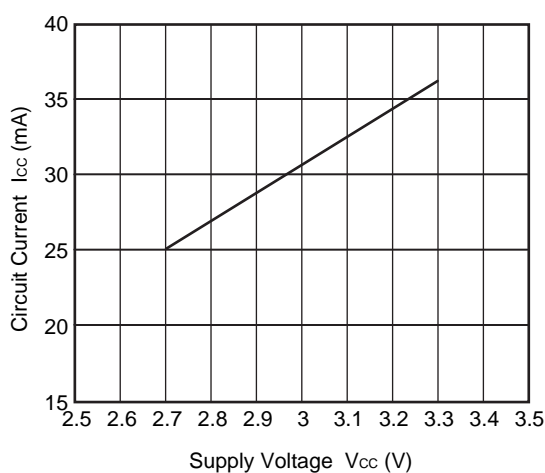

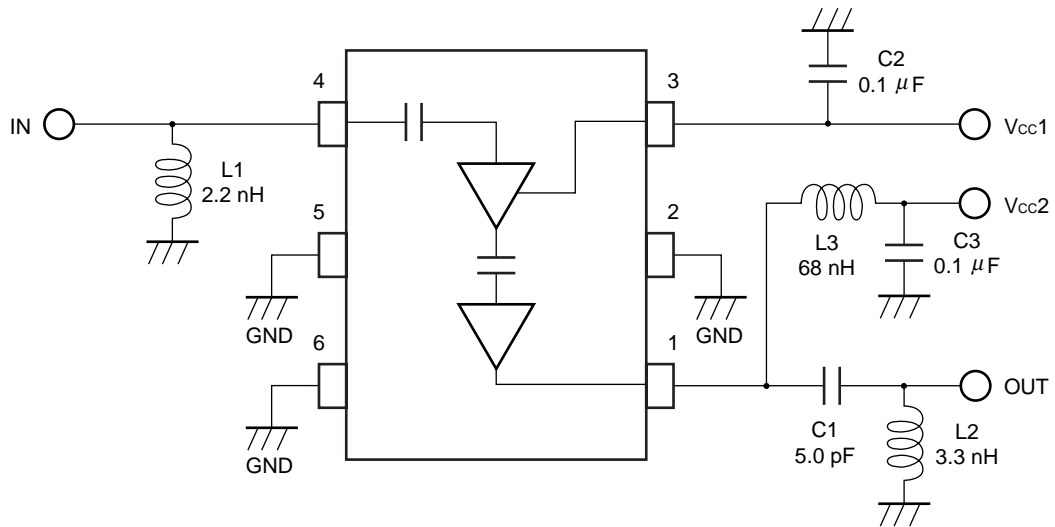

CIRCUIT CURRENT vs. SUPPLY VOLTAGE



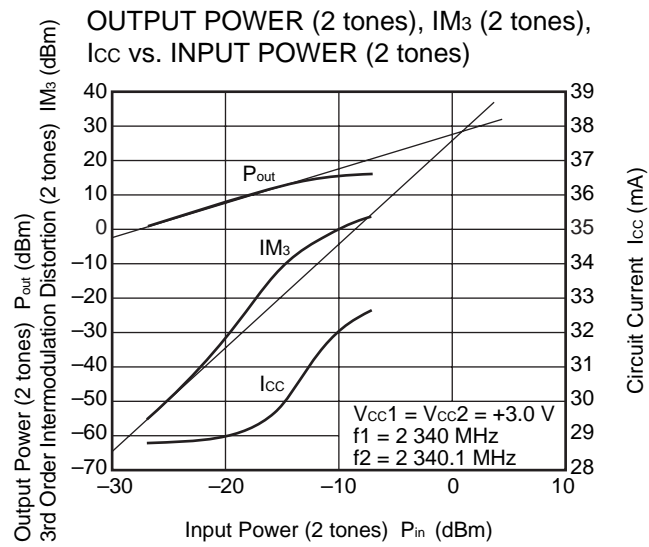

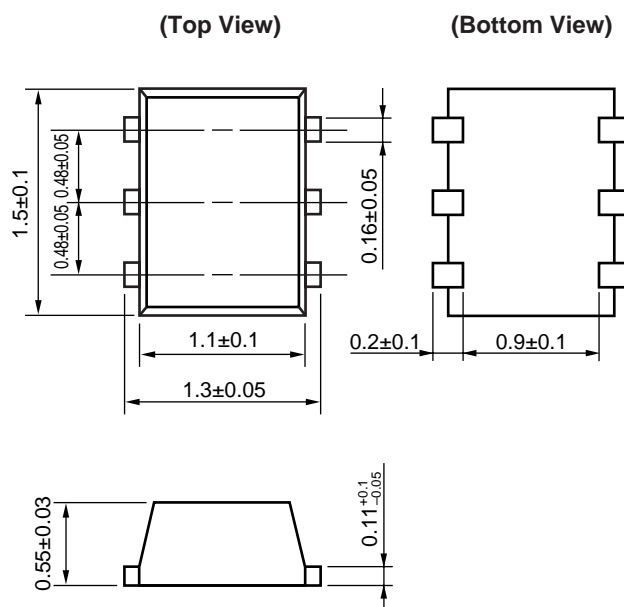
