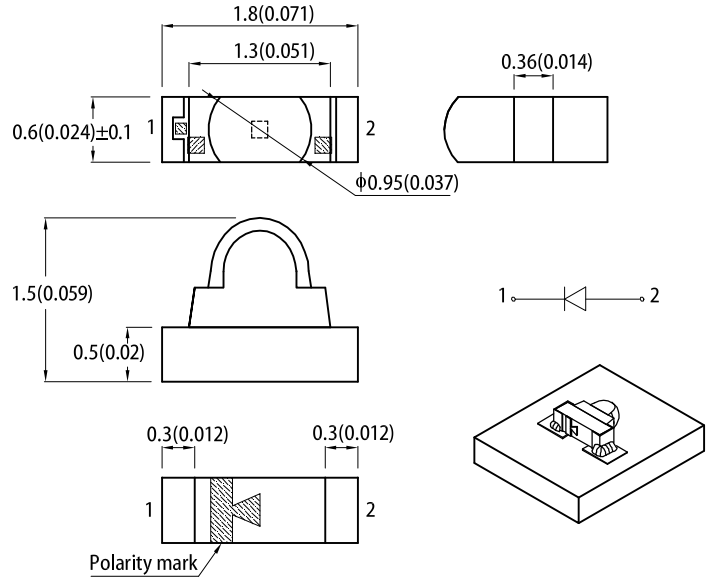

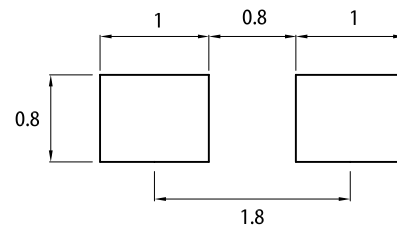

5. For right angle SMD LEDs, the solder stencil should be at least 5mil in thickness, to prevent poor solder wetting due to insufficient solder paste.

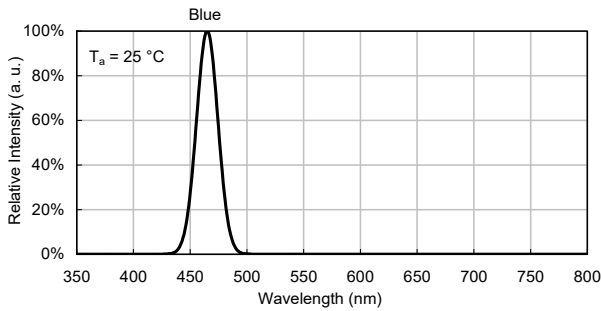

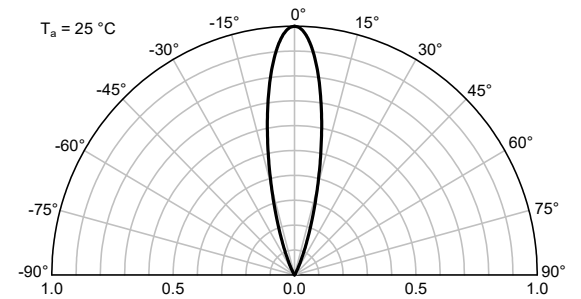

#### RELATIVE INTENSITY vs. WAVELENGTH

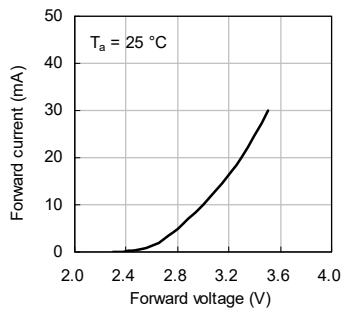


#### SPATIAL DISTRIBUTION

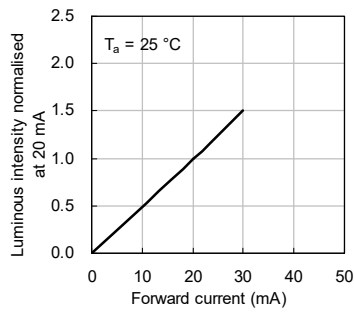

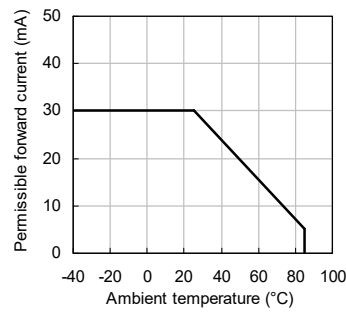
Forward Current vs. Forward Voltage



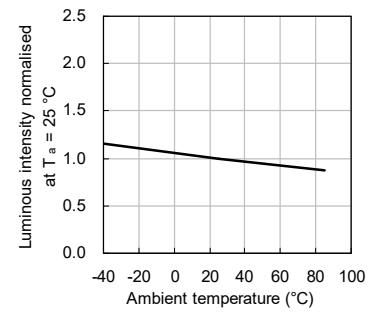
Luminous Intensity vs. Forward Current



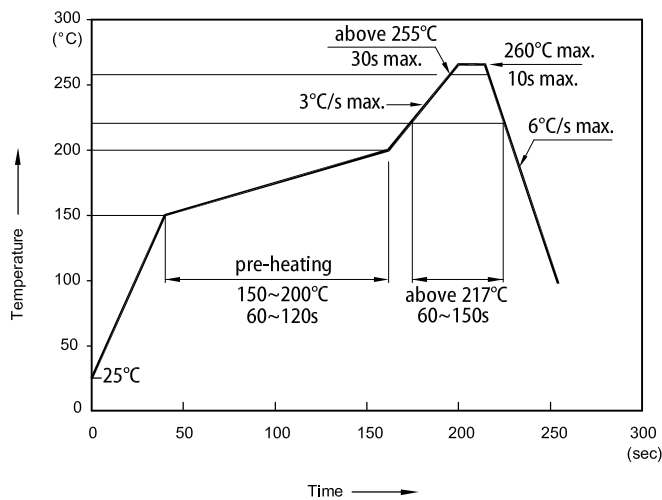
Forward Current Derating Curve



Luminous Intensity vs. Ambient Temperature

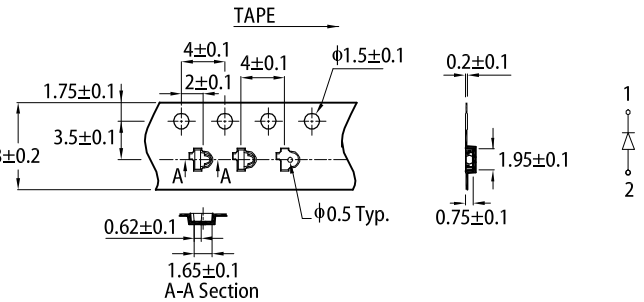


#### REFLOW SOLDERING PROFILE for LEAD-FREE SMD PROCESS

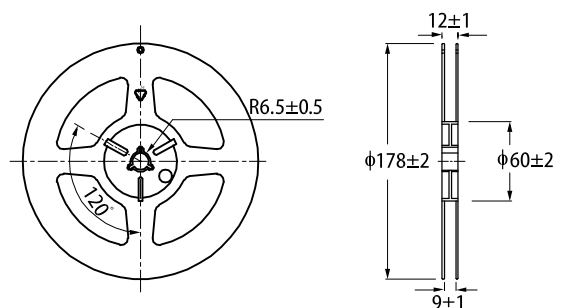


- Notes:

  3. Reflow soldering is recommended. Other soldering methods are not recommended as they might cause damage to the product.

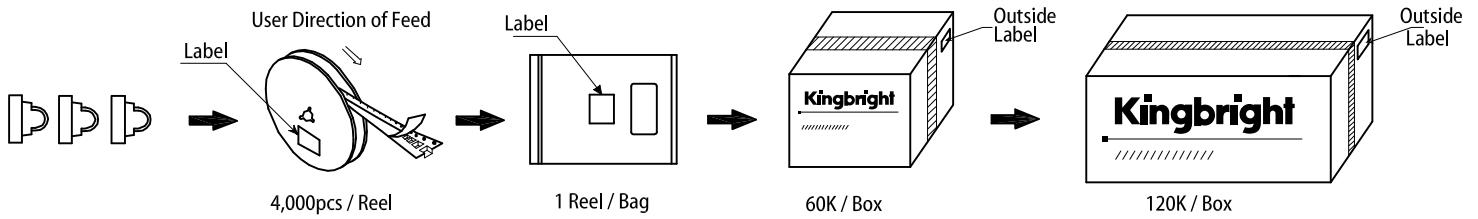
#### TAPE SPECIFICATIONS (units : mm)
